Conjunto de 5 áreas de importancia para las aves esteparias, de relieve llano o suavemente ondulado, ubicadas en la Comarca de Almansa, distribuidas en los términos municipales de Almansa, Montealegre del Castillo, Higueruela, Hoya-Gonzalo, Chinchilla de Montearagón, Alpera y Corral Rubio.

4.2 Quality and importance

Conjunto de áreas cultivadas con pequeños enclaves de matorral y coscojar intercalados, de gran interés para las aves esteparias, tanto por la diversidad de especies y cuantía de sus poblaciones, como por su distribución marginal, en el límite oriental del territorio de Castilla-La Mancha. Destacan las poblaciones de Avutarda que se asientan en todas las zonas delimitadas, así como las poblaciones de Sisón, y Ortega existentes en las áreas esteparias de Hoya Gonzalo-Higueruela, Almansa y Montealegre del Castillo, y la población de Alcaraván de esta última área esteparia.
